Brief Description: This course examines the role of the EU as a global actor on migration and asylum. It considers human mobility in historical perspective and analyses critically the responses (universal and regional) thereto. The course is intended to provide students with a conceptual framework and relevant methodology for the analysis of contemporary debates on migration and asylum in the context of EU policies.

ASSESSMENT



Migration Policies of the EU will be assessed by **a mid-term exam, active class participation, and a final exam.**

- The **mid-term exam** will be a test/short answer exam that counts for 20% of the overall mark
- **Active class participation** on a weekly basis will amount to 20% of the overall mark.
- A **final exam** will take place at the end of the second semester (April-May exam period) that counts for 60% of the overall mark. This will be an oral exam and it will consist of either an essay question or a case-study.

June Resit Exam: Students who do not pass the course in the April-May ordinary exam period will have the chance to resit the exam during the June exam period. The June exam will be like the April-May exam.
