Through your **active participation**, you will understand one of the more challenging international processes: how 27 countries have agreed to synchronise their security and defence together. Studying this process is beneficial for **EU and non-EU citizens alike**.

### **This demanding course is based on your commitment**

By working on selected specialised literature **at home** you will be prepared to develop analytical competences **in class**. You will master essential concepts which will nurture informed discussions through a variety of activities. You will also learn to write the reports used in International Organisations.

### **We will pursue an active and practical approach.**

You will perform roles that will serve you on your future work. Each session will be led by a **panel** of students, and we will extensively use Artificial Intelligence tools to broaden and deepen your understanding of IR. you will demonstrate your essential IR concepts for the FINAL EXAM which will be individual and **ORAL**.

### **We will encompass foreign affairs, internal and external security.**

We will understand the framework encompassing the EU **Foreign Affairs, internal Security, Defence** and other policies by analysing EU legislation, policies, national positions, strategies, elements supporting decisions, We also focus on the coordination between the Justice and Home Affairs and the Security and Defence policies and analyse different ways the EU is organising itself to tackle **transnational challenges**.
