Course description:

This subject covers the specificities of an E-commerce vs a conventional business. The goal is to make students aware of the adjustments in mindset, value proposition, technology, operations, organization, people, marketing & commercial efforts necessary to make an E-commerce work.

The subject has an eminently practical approach, where the understanding of most concepts will be pursued by working on real life cases. The weekly assignments will greatly determine the final grade of students.

EDUCATIONAL ACTIVITIES.

CLASSROOM (30h).

1. Lectures by Professor (12h).

Lectures are given by the professor on the themes indicated in the syllabus with the help of the blackboard, power point presentations, videos and animation movies. All the material will be available through ADI.

2. Lectures by External Guests (8h).

- Success / Failure cases presented by experts.
- Expert Knowledge lectures given by experts.

3. Analysis of team work (Case work) (8h).

The class will be divided in teams, and each team will make a brief pitch on who how to apply the specific area covered by the session topic, to a real case. After the pitches, there will be a discussion with the class and the professor will provide further insights to find the best solution. Teams must have prepared the sessions beforehand, and their contributions must be meaningful and sound. Teamwork is strongly required.

4. Evaluation (2h).

Exams or activities to assess the successful accomplishment of the objectives.

PERSONAL WORK (30h).

The evaluation of this subject is to happen on a continuous way. Thus, the students are expected to work weekly in order to be ready for the next session and be able to integrate all knowledge that is necessary to properly follow the subject. Falling behind is easy. Staying on top of things should roughly take one and a half hours of personal work plus one hour of teamwork per week.

1. Students must do research on given topics, that will allow them to bring valuable insights to their teamwork.

2. Students must contribute to their teams discussion and works, and be available to explain and discuss points of view with their teammates.



3. Every student will give at least a pitch presentation in front of the class.

TEAM WORK (14h).

Team work is a must. Students will be evaluated by the results of their teams, as well as by their own performance. All students are expected to contribute to the work of their teams in a weekly manner, so that teams can bring sound assessments to the class and have a meaningful discussion with other teams.

PERSONAL TUTORIALS (1h).

Available to students prior appointment.

GRADING.

Every student will be graded from 0 to 10. The subject is designed for continuous evaluation. All students can attain a grade of 10 if they put down some hard work on a weekly basis. Teamwork quality, team members contribution, class participation and seminars will be the four main drivers of grading. They will mix to render the final grade, as follows.

- **Team assignments** (case work, the grades of your team) **7 points**
- **Lectures by guests** (attendance mandatory, 4 seminars, 0.5 points each) **2 points**
- **Peer review** (the grade your teammates will award you) **±1 point**
- **Golden point** (continuous evaluation, to be awarded by the professor for class attendance and participation) ... **1 point**

Guest lectures will be graded on the basis of attendance & participation.

Peer review. All students will evaluate the work of their teammates during the semester. Hard work, meaningful contributions and good attitude will be rewarded. Outstanding evaluations of teammates will render up to one extra point in the student's final grade. Poor evaluations will deduct up to one point from the students final grade.

Golden point. Will be awarded by the professor on the basis of class attendance, class participation, and overall attitude. It is an extra point and thus, it is not necessary to attain a full score of 10 points.

SUCCESS OR FAILURE.

Students whose grades are below 5 after the classes period, have failed the subject and will have to report for the June examination.

Students whose grades are over 5, and want to improve them in December, will be granted the possibility to send a project that will affect their final grade in a range of ± 2 points.

Class attendance is mandatory. Students who repeatedly fail to attend classes or teamwork sessions will fail the subject.

HONESTY IS THE BEST POLICY.

Ethics Committee Provisions Against Plagiarism and Copying.

We value honesty. Without it, there can be no trust or any meaningful social relations. Therefore, the School expects honesty and fairness from all of its members: professors, non-academic staff, and students.

- A failing grade for the piece of work or the whole course

Those students who have failed the subject will be given the opportunity to take an exam in June. The exam will be designed to allow students to pass the subject with a maximum grade of 5 points.
