



## PRESENTACIÓN

- **Breve descripción de la asignatura:**

This class will be dedicated to the philosophical study of human beings and the human condition. We will discuss and evaluate various philosophical responses to the following questions:

- 1) what are human beings? Are they animals? Are they purely material beings or do they have an immaterial soul?
- 2) what is the purpose and end of the human life? Does death constitute an obstacle to the meaningfulness of the human life?
- 3) what are the powers of a human individual? Do we have Free Will? Are we really rational?
- 4) how essential to the human condition is the experience of living as a group or community? What are the roles of family, friendship, religion, art, politics, in the constitution and structure of a properly human community?

At the end of the course students are expected to be capable of:

1. identifying the anthropological presuppositions that underlie various contemporary debates in ethics and politics
2. understanding and elaborating sophisticated arguments for or against various philosophical conceptions of human beings
3. achieving a high level of coherence and argumentative justification in their own understanding of human beings, in order to get closer to truth

The work in both semesters will include careful reading and discussion of the texts indicated in the program as "mandatory bibliography". Students are required to attend classes having read the mandatory texts corresponding to the subjects to be discussed in class. We will have lectures and discussion-based classes.

## ACTIVIDADES FORMATIVAS

The course is 6 ects and thus requires 150 hours of student work.

44 hours of this work will be dedicated to in-person lectures.

66 hours of work will be dedicated to reading through required texts.

40 Hours will be dedicated to the students' revisions and exams (partial and final).

## EVALUACIÓN

### ORDINARY CALL

The course will be graded on a 10 points scale.

Each semester, you will receive an average grade. The annual grade will be the average of both semesters.

- **semestrial exam** (December and May): written exam **70%**. The December exam will concern the chapters seen in the first semester. The May exam will concern the chapters seen in the second semester. Both exams will contain a part with an essay question and a second part with multiple choice questions (bad answers discounting points).

- **reading tests** (during the year): **30%**. You will have to read a chapter or a paper every week, and there will be a short reading test from time to time (unanounced).

- **optional presentation** (last class of the second semester): for a **bonus of up to 10%** of your second semester grade. On a voluntary basis, students who want to do a supplementary work on some topic of anthropology studied during the year can contact the professor. The professor will validate the topic suggested by the student (example: meaning of life, free will, etc.), and will assign a paper to be read on this topic. The student will have to read the assigned paper (on this topic) and prepare an oral presentation of 7 to 10 minutes, which will consist of a presentation of the argument of the paper and a personal contribution to the philosophical debate (either in agreement or in disagreement with the paper). More guidelines will be provided about how to write a philosophical essay.

Students with special educational needs must first contact the Coordinación de Estudios of the faculty / school, in order to obtain the corresponding authorization for adaptations (for example, being allowed extra time in exams). This authorization must then be sent by the student to the professor. It is recommended that this procedure be carried out at the beginning of the semester.

## EXTRAORDINARY CALL

If students fail to reach 5 points in the semestrial (or annual) average, they may sit for an exam in the "Extraordinary Call".

Each semester can be retaken separately. Students who choose to retake a semester must retake at least the part of the corresponding semestrial exam (70%), which will have the exact same form as in december (or may respectively), with different questions. They can also decide to retake the part of the reading tests (30%): in that case they will have a new reading test of 20 questions that can bear on any of the readings of the corresponding semesters. Otherwise, they can choose to keep the average grade for reading tests that they received during the semester.

The bonus grade of the optional presentation doesn't count in the extraordinary call. There is no option to do any supplementary work in june.
