Through case studies, debates, screenings of different productions, and practical exercises, students will be encouraged to reflect on the boundaries of fiction.

EDUCATIONAL ACTIVITIES

Theoretical and practical lessons (28 hours)

This course is organized into two-hour theoretical and practical sessions. These classes will primarily combine the case study methodology with practical exercises. Students will be encouraged to reflect on specific topics related to fictions based on true events through debates and analysis of specific texts or audiovisual products. In some cases, these will be worked on in class, but in others, students will be expected to have read or viewed them at home.

Autonomous work (44,5 hours)

These hours include the weekly time dedicated to homework (reading, viewing, or writing), as well as the time needed to carry out an individual analysis of a work of fiction based on real events and a final proposal, in pairs, of a fictional production based on a journalistic book.

Final presentations (2 hours)

Final presentations will be public during the theory class slot, April 11th from 12:00 to 14:00.

Tutorials (0,5 hours)

It is important for students to meet with the professor to plan and monitor their final project.

ASSESSMENT

ORDINARY SESSION

The final evaluation grade will be the sum of the following activities:

- **30% Exams** = Narrative analysis (20%) + Oral exam (10%)

- **60% Tasks** = Practical exercises both in class and at home (30%) + Final project (30%)
- **10% Participation** = Taking part in the lectures, attending the workshops and giving feedback to your classmates in their presentations.

Maximum grade, 10; minimum to pass the class, 5.

The narrative analysis, the practical exercises and the final project will be evaluated separately. Passing the narrative analysis and the final project is required to pass the course.

EXTRAORDINARY SESSION

Students who do not pass the course in the ordinary session will have to an exam in the extraordinary session. The exam will consist of several short questions related to the content covered in class and in the course assignments. In this exam session, the exam result will be 100% of the course grade.
