## ACTIVIDADES FORMATIVAS

### General overview of formative activities

In this course, an active, hands-on approach is adopted to ensure that students acquire a working knowledge of legal English vocabulary, concepts and documents. Each class usually begins with a brief presentation of a specific subject within legal English (e.g. contract law, real estate law, etc.), in which the main vocabulary and concepts are explained, and the students are given the opportunity to look at authentic documents, watch documentary videos, or listen to lawyers at work. After this, the students will work on a range of reading, listening, reading and writing activities, in order to consolidate their knowledge of international legal English. Students will also have the opportunity to practise the vocabulary and ideas they have learned during each class by taking a specially-designed set of online tests (one of these has been made available for inspection in ADI - Online Tests).

There will be a special focus on preparing for the evaluated writing and speaking activities:
