# **PRESENTATION**

**Description**: IIRR students need to be introduced into the inner legal layer of certain international actors because the systemic view of international relations remains too broad of an analysis. Since the EU wields the might of 27 European States, including that of the one hosting this university, an introduction to it is unavoidable.

When opening the EU and looking into its inside, we will find that the institutional machinery we are contemplating is one of the most sophisticated the World knows of. The particular history of the European continent combined with the ambition of the goals to be achieved has required such a degree of creativity that in the EU the traditional concepts that structure power (e.g. Democracy, Sovereignty) have been pushed to their limits. All this is done through public law.

In this class, we will learn how the latter –public law– shapes the former –the EU–. The goal is that students understand the architecture and functioning of the institutional laboratory that the EU is through its most fundamental element: EU law.

# COMPETENCES

# **EDUCATIONAL ACTIVITIES**

The goals we aim at are:

- That students know the history, nature, and institutions of the EU.
- That students understand the main concepts building the institutional complex of the FII
- That students grasp that the EU as a political project is founded upon and developed using the law. Students will be provided the tools to link EU political activity with the legal instruments framing them.

The learning method includes:

- **Student's personal and constant study**: students will only succeed if they read and study materials personally, thoughtfully, and timely.
- Lectures: in the lectures taking place on Tuesdays, the teacher will expose and analyze the main contents. His explanations may extend to the first portion of the reduced group classes.
- Thursday sessions: these sessions will approach the same content of the lectures but from an angle that connects it with the real institutional-political life of the EU.

# **ASSESSMENT**

# **ORDINARY**

Student performance is assessed according to these percentages:

- mid-term exam(s) (20% of the final grade)
- final exam (50% of final grade)
- class participation (30% of final grade)

**Class quizzes**: at least one mid-term will be sat, perhaps more depending on how the class is progressing; in such a case they would be called with a week of anticipation.

**Final Exam**: it will be oral and will be voice-recorded. Two to four concise questions will be asked.



Class participation: The professor will take notes on student participation and attendance. For the sake of ease, participations will be classified into 0, 1, 2, and 3 interventions depending on the value of their contribution. Since group classes make little sense if students do not participate, students will be asked regularly and graded accordingly.

# Important:

both of the next two conditions need to be met in order to pass the course: at least a score of 5/10 should be achieved in the final exam, and at least a score of 5/10 should be achieved in the global course grade.

#### **EXTRAORDINARY**

Student performance is assessed according to these percentages:

- final oral exam (70% of final grade)
- class participation (30% of final grade)

In order to pass, students must achieve a global score of, at least, 5 out of 10.
