



## INTRODUCTION

**COURSE DESCRIPTION:** This elective course provides students with an overview of the different international healthcare systems and the different nursing roles in those contexts. Nursing professionals play an active role in healthcare institutions' management, administration, and leadership. Therefore, nursing students must understand the different levels of management and administration of services and the essential functions of nursing services at the international level. Through this introductory course, students will be provided with basic knowledge about the different international healthcare contexts and the role of nursing within them.

## LEARNING OUTCOMES (Competencies)

### COMPETENCIES OF NURSING GRADUATES

#### SPECIFIC COMPETENCIES

## **ESSENTIAL COMPETENCIES**

**CB2.** Students must have the ability to gather and interpret relevant data (usually within their area of study) to make judgments that include a reflection on relevant social, scientific and ethical topics.

**CB4.** Students must be able to transmit information, ideas, problems and solutions to specialized and general audiences.

**CB5.** Students must develop the learning skills required to undertake subsequent studies with a high level of independence.

## **PROGRAM**

The course program will be based on seminars given by international experts worldwide. They will provide insight into the functioning of the healthcare system in their country of origin and the different nursing roles and development opportunities in these contexts. This information is ideal and relevant for students, as they will be able to evaluate the option of developing their professional activity abroad in the future by having a global perspective of the functioning of the various health systems and the role of nursing in them.

The different sessions and speakers will be specified at the beginning of the academic year and reflected in this section.

## **EDUCATIONAL ACTIVITIES**

### **EDUCATIONAL ACTIVITIES**

#### **CLASSROOM TEACHING ACTIVITIES**

##### **1. Lectures** (0,8 ECTS 20 hours)

International experts from all over the world will lecture using different sources. These classes will be done through PowerPoint presentations and videos where the professor will explain the relevant issues of the presentation. The lectures will provide an overview of the healthcare system and the role of nursing in the speaker's home country. The active participation of the students will be sought.

##### **2. Debriefing**

After the lecture, the professor responsible for the course will debrief the students about the speaker's presentation. Students will be divided into different groups and have to work on a list of questions the professor will give them that same day in class. Once this work is done, the answers of the different groups will be commented on aloud, encouraging interaction and debate among students.



### **3. One-to-one tutorials** (0,16 ECTS 4 hours)

Each student may have personal interviews with the lecturer to help with personal study and learning.

## **II. PERSONAL AND INDIVIDUAL STUDY** (1,96 ECTS 49 hours)

The student will be responsible for the organization of his/her work and knowledge acquisition at his/her own pace. Thus, the student will have to study and review the program and solve doubts individually in tutorials or groups.

## **ASSESSMENT**

### **1. Evaluation of the Theory program** (0,08 ECTS 2 hours)

Theory element: counts 80% of the final mark

The evaluation of the theory program will include the following:

- **Essay:** the student will make a reflection on one of the health systems that have been addressed during the course.

### **2. Participation**

Participation will constitute 20% of the final grade. This will be evaluated through the different activities related to the seminars (attendance, professor's questions...).

### **3. Final Grade**

According to the Royal Decree 1125/2003, article 5, marks will range from 0 to 10, including one decimal point and with the following corresponding qualitative grade:

**0-4,9: Fail (F).**

**5,0-6,9: Pass (P).**

**7,0-8,9: Merit (M).**

**9,0-10: Outstanding (A), with Honors if that is the case**

#### **Evaluation of the extraordinary call**

There will be an extraordinary assessment in June for those who do not pass the course. The Extraordinary assessment will follow the same assessment criteria as the Ordinary one.

#### **\* Students with special learning needs**

Students with special educational needs must first contact the Office of Academic Affairs of the School of Nursing to obtain the corresponding authorization for accommodations. This authorization must then be sent by the student to the course professor. It is recommended that this procedure be carried out at the beginning of the semester. Accommodation will be provided for students with special learning needs, either regarding the methodology and/or evaluation of the course, but they will be expected to fulfill all course objectives.
