INTRODUCTION

Course description:

This intense seminar will explore the entire range of conservation themes from the protection of a rural landscape and its built vernacular to a dense urban environment with individual architectural monuments. Architectural heritage makes places unique, creates a sense of home and links us to our past while reinforcing communities; but is fragile and must be vigorously protected and promoted through an understanding of underlying values, communication, exemplary projects, research and education. But historic places must also live and thrive, thus it is essential for contemporary architects to know how to appropriately intervene.

The seminar offers an overview of technology and associated strategies in the conservation of buildings including associated and topical technical issues in conservation (sustainability, management, maintenance). Case study examples will be used extensively to illustrate different concepts and key approaches currently used in built heritage conservation as well as various techniques for intervention: preservation, restoration, rehabilitation.

- Lecture II - *An interdisciplinary challenge. Cases studies.*
- Lecture III - *Architectural conservation and new uses.*

EDUCATIONAL ACTIVITIES

This week-long intense seminar will be a balanced mixture of **lecture, discussion, and project activities**. The lectures will introduce participants to the theories, context, terminology, and history through both good and bad examples. Later, the interactive discussions are intended to stimulate thought and provoke an exchange of ideas and provide feedback for both the participants and the instructor. Finally, the third component is to learn by doing. A short project will be selected and the theories applied with the aid of the instructor. This project will be developed in teams to explore the entire range of conservation themes from the protection of a rural landscape and its built vernacular to a dense urban environment with individual architectural monuments. Each afternoon is dedicated to working on this project with the aid of the instructor and the lectures are structured to support this project. Final projects will be presented on the last morning of the course with invited guest jurors.
