RESULTADOS DE APRENDIZAJE (Competencias)

ACTIVIDADES FORMATIVAS

In addition to providing a comprehensive theoretical foundation through classroom-based instruction, this course is designed to foster a dynamic and engaging learning environment that extends well beyond traditional lectures. Participants will take part in structured group learning activities that encourage collaboration, discussion, and the practical application of concepts in team settings.

The course also incorporates unstructured—yet carefully guided—individual learning experiences, allowing participants to explore topics independently, reflect critically, and develop their own perspectives while receiving support and direction from instructors. Complementing these activities is a strong emphasis on self-study, encouraging learners to deepen their understanding through independent research, reading, and preparation.

To bridge theory and practice, the programme further includes a variety of experiential learning opportunities outside the classroom. These may include company visits, exposure to real-world organisational environments, and presentations or guest lectures delivered by experienced practitioners and industry professionals. Such activities are intended to provide practical insights, connect academic concepts with current professional practice, and enrich the overall learning experience through direct interaction with the business and professional community.

CONVOCATORIA ORDINARIA

CONVOCATORIA EXTRAORDINARIA

- The extraordinary exam typically follows a similar structure as the standard exam.

Students who:

- 1) ... did not write the standard exam, but the extraordinary exam, will be evaluated following the standard proceeding (i.e.: 25% presentation + 20% written assignment + 55% final exam).
- 2) ... write the extraordinary exam because they want to improve their grade, will be evaluated following the standard proceeding. Note: If the extraordinary exam turns out to have a worse grade than the one in the standard exam, the grade from the extraordinary exam is the one that counts.
