



## INTRODUCTION

**Brief description:** "Introduction to Teaching and Research Collaboration II" is a course included within the Bachelor's Degree in Nursing and, specifically, in the Diploma Leadership, Research, and Teaching (LID). Therefore, it is aimed at nursing students (fellows) seeking to develop leadership, research, and teaching skills. It is a fourth-year, annual course, with a credit allocation of 3 ECTS. Its educational activities include both theoretical and practical content related to the attributes of the LID diploma.

**Series of Expository-Participatory Seminars (12 hours / 0.48 ECTS)**

A participatory seminar is an educational and training activity where students actively engage in the learning process through discussions, group work, practical exercises, and other interactive dynamics. This will foster:

- **Active Interaction:** Attendees have the opportunity to share their ideas, experiences, and opinions, enriching the learning process.
- **Collaboration:** Teamwork and collaboration among participants are encouraged, facilitating the exchange of knowledge and skills.
- **Discussion and Debate:** Sessions include discussions and debates where topics are analyzed and reflected upon, promoting critical thinking.

Various pedagogical techniques, such as case studies, simulations, role-playing, and other interactive methods, will be employed to make learning more dynamic and effective.

## **Practice Itinerary (38 hours / 1.52 ECTS)**

Each student will be assigned a tutor with whom they will develop the planned leadership, research, and teaching activities throughout the course. The student will record and reflect on their activity through the Personal Portfolio.

## **OFF-SITE TRAINING ACTIVITIES**

### **Preparation for Seminars and Portfolio (25 hours / 1 ECTS)**

To adequately prepare for and benefit from the seminars, the student must work on the material provided by the professor who will conduct the session. Additionally, the student should dedicate the necessary time to preparing a portfolio that reflects, according to the guidelines proposed, their experience holding a Student Fellow at the Faculty of Nursing at the University of Navarra. The portfolio will be evaluated by the professor responsible for the course using a rubric designed for this purpose.

## **EVALUATION**

### **ORDINARY CALL**

**1) Teaching portfolio:** 60% of the final grade. The portfolio must be submitted by email to the course instructor on April 15, 2027, before 14:00. The portfolio must be defended on the date indicated by the course instructor. See the Evaluation Rubric\_Portfolio, available in the "Evaluation" folder on ADI.

Prior to submission, the tutors must have approved the portfolio (see the V<sup>o</sup>B Portfolio document. It must be attached, signed by the tutor, on the same day of submission).

**2) Evaluation of the Internal Student's performance and learning by the tutor:** 30% of the final grade. See the Evaluation Rubric\_Practical Pathway, available in the "Evaluation" folder on ADI.

**3) Attendance and active participation in seminars:** 10% of the final grade. See the Evaluation Rubric\_Attendance and contribution in seminars, available in the "Evaluation" folder on ADI.

### **EXTRAORDINARY EXAM**

**Teaching portfolio:** 100% of the final grade. Submission of the portfolio is mandatory. The final grade will be determined based on its oral defense. (Assessment rubric)
