**Breve descripción:** This course is intended as an introduction to the field of international organizations and their role in the international sphere, as well as their importance for the domestic policy process. Its purpose is to give you both a sense of the general theoretical concepts used in the field, and how they apply to a group of international organizations that can be deemed as highly relevant in their respective areas. To that end, it will cover a scope of these organizations in some detail, ranging from truly "global" organizations like the United Nations, the World Trade Organization, and the World Bank to more "regional" organization like NATO, USMCA, or Mercosur. In that context, the course will also treat the potential emerging conflict between globalism and regionalism in international organizations.

Presentations must be handed-in via email to the teacher on the day of your presentation. The ethical standards of a scientific working style apply, and the use of AI in the creation of content must be duly acknowledged.
- The *final exam* will be based on the lectures, class discussions, and texts. All texts (and presentations) will be made available on ADI.
- *Contributions in class* are compulsory. Students are expected to actively participate in the lectures and debates.
