



PRESENTACIÓN

Breve descripción: This course provides the basic tools and concepts to analyze the global political economy and its evolution over time. To do so, it first introduces students to some key economic theories that form the basis for the dominant analytical framework in international political economy. From there, the second part traces the evolution and eventual domination of a European-based world economy. The third part focuses on recent dynamics of the global political economy, highlighting a series of important structures and frameworks.

- *Contributions in class* are evaluated with 1 point towards the final mark.
Students are expected to actively participate in the lectures and debates.
