PRESENTACIÓN

Breve descripción: The objective of this course is to offer students the basic analytical framework to analyze different political cultures, social structures, democracy, and institutions. These outlines are then applied to understand the principal differences between democracy and authoritarian forms of government, differences and similarities among various democratic forms of government, the internal processes of democratic decisionmaking, and the principle lines of global conflict. We will use theoretical arguments and a wide range of case studies to address the related questions: Why are some countries democratic and others not? How does democracy affect political conflict and economic development? Why do some countries centralize power while others threaten to fall apart through secession and civil war? We will use examples from a wide range of countries including Spain, Germany, Iraq, and the United States. The lessons drawn from these countries will prepare you to analyze other countries of your own in a paper assignment. The course has two goals: (1) to guide students to analyze and compare complex political processes through frequent reading and discussion, and (2) to serve as an introduction to and foundation for advanced study in political science and related social sciences. At the end of the course, you should be able to analyze political events around the world, drawing on the theoretical explanations provided in class.
