



PRESENTACIÓN

Breve descripción: This course is an introduction to the interrelated fields of public finance and public policy. Its purpose is to give you a profound overview of the responsibilities and limitations of government in a market economy. It will cover a scope of important topics in traditional public finance, ranging from public goods, externalities, unwanted markets, and asymmetric information, to the quest for social justice in terms of social insurance, moral hazard, and social mobility. Public choice and political economy concepts are further applied to evaluate how politics affects societal efficiency and income distribution, attempting to explain the functioning of government itself.

Grading activities

- Theoretical lectures are imparted and compulsory!
- The *final exam* will be based on the theoretical lectures. All lectures will be made available on ADI.
- *Group presentations* are to be given in groups of several students (assigned by the teacher at random) on a specific topic and a corresponding set of papers. These are all related to the topics covered in class. Presentations (and essays) are to effectively summarize the current state of knowledge in this specific area in the form of a brief literature review. Via an individual literature search, each group is to take the review further than what is offered in the original papers. Please take note that this is a group activity. Presentations will be 15 minutes each, followed by 5 minutes of questions from the teacher, and a 5 minute round-off discussion in class.
- The *group essay* is to be written by each group of students with a maximum of 5.000 words. The essay will be based on the presentation. The ethical standards of a scientific working style apply, and the use of AI in the creation of content must be duly acknowledged. [Citation style for papers](#).
